Confirmed Approvals for Service Required since November meeting

- 1. Trim and thin trees (part of tree proposal in reserve study) Maumee
- 2. 492 St. Clair roof leak issue and address downspout to right-side chimney, remove shingles and counter flashings, install ice/water shield membrane exposed areas, install close matching shingles to perimeter of chimney where removed, seal tie-ins between new and existing shingles, fabricate and install new chimney counter flashings; clean all debris from work site and dispose at legal landfill.

Photograph Property: Tom Sabella seeking photography services to document property before demolition and construction begins.

Trash Collection: Discussion about requesting options from City for DPW services during the construction and following the replacement of our back drive; the intent to restricting large vehicles on our private drive.

Parking: We consider issuing stickers/decals for owner/resident vehicles listed on owner's form to identify vehicles parked in the drive; will help to identify owner if restricted parking during the construction requires that a car be moved.

Materials used on exterior walls – Reportedly Grosse Pointe City shared information that they will make every effort to avoid cheap for the new construction of the DPW building.
